**EXECUTION** as from the date of signature of each Order, unless the Order concerned provides otherwise.

# CALL FOR TENDERS FOR THE PROVISION OF CONSULTANCY SERVICES ON ACCESSING FUNDS UNDER OPERATIONAL PROGRAMMES IN BULGARIA 2018/AO/73

# A. BACKGROUND

The Joint European Commission (EC) and Council of Europe (CoE) Programme "ROMACT – Building up political will and understanding of Roma inclusion at local and regional level" (ROMACT) (hereafter referred to as "the Programme") is pursuing the ROMACT Programme to build the capacity of local authorities to develop and implement plans and projects for Roma inclusion and aim to promote the integration of Roma at local level.

The Programme pursues the following objectives: improving local democracy, accountability, inclusiveness and responsiveness towards Roma citizens and thereby improved delivery of services.

The Programme will end on 31 March 2021.

The Programme is comprised of several elements of support to regional and local authorities and Roma communities focusing on:

- capacity building;
- establishment and enforcement of mechanisms and processes promoting and ensuring good governance standards and ownership by local authorities of effective integrated development efforts covering education, employment, healthcare, housing, urban development and culture;
- equipping local authorities with tools, knowledge and skills to overcome the challenges and barriers in regard to the needs of the Roma;
- improving the efficiency, effectiveness and sustainability of local policies, measures and delivery of services; and
- supporting cooperation between municipalities willing to design and implement jointly concrete integration measures and projects.

The Programme's activities will take place in 2 (two) countries: Bulgaria and Romania in a number of municipalities in each country.

In each country, a National Support Team ("NST") will be formed, consisting of one or more National Project Officer(s), National Facilitators' Coordinator and a number of Facilitators.

The National Support Team will be supported by a number of consultants ("Service Providers") providing expertise.

The Council of Europe is looking for a maximum of *ten* Provider(s) (provided enough tenders meet the criteria indicated below) in order to support the implementation of the project with a particular expertise on accessing funds under operational programmes in Bulgaria and implementing projects funded under the mentioned sources, in particular the following funds:

- European Social Fund
- European Regional Development Fund
- Cohesion Fund
- EU funds managed by European Commission
- Other funds

And, in particular, the following Operational Programmes:

- Operational Programme Human Capital2007 2013 and 2014 2020 / Sectorial Operational Programme Human Resources Development;
- Operational Programme Regional Development, 2007- 2013; Operational Programme Regions in Growth 2014 – 2020; Cross-Border Programmes;
- Operational Programme Large Infrastructure /Sectorial Operational Programme Environment 2007-2013/2014-2020;
- Programmes managed by European Commission,
- Other programmes: Swiss Fund, EEA Norway Grants.

This Contract is currently estimated to cover up to 150 activities, to be held by 31 October 2021. This estimate is for information only and shall not constitute any sort of contractual commitment on the part of the Council of Europe. The Contract may potentially represent a higher or lower number of activities, depending on the evolving needs of the Organisation.

For information purposes only, the total amount of the object of present tender should in principle not exceed 150,000 Euros for the whole duration of the Framework Contract. This information does not constitute any sort of contractual commitment or obligation on the part of the Council of Europe.

# **B. SCOPE OF THE FRAMEWORK CONTRACT**

Throughout the duration of the Framework Contract, pre-selected Providers may be asked to:

- Provide expertise to the ROMACT Management team, the NSTs and the Programme's stakeholders on matters and in fields of accessing funds under Operational Programmes in Bulgaria and implementing projects funded under the mentioned sources
- Prepare proposals and recommendations to the NST and ROMACT Management team for activities in the field of accessing funds under Operational Programmes in Bulgaria and implementing projects funded under the mentioned sources;
- Provide training on accessing funds under Operational Programmes in Bulgaria and implementing projects funded under the mentioned sources;
- Assist and support the development of project proposals for submission to relevant Calls for funding and, in cases of already funded projects, assist and support the implementation thereof;

The above list is not considered exhaustive. The Council reserves the right to request deliverables not explicitly mentioned in the above list of expected services, but related to the field of expertise object of the present Framework Contract.

In terms of quality requirements, the pre-selected Service Providers must ensure, inter alia, that:

- The services are provided to the highest professional/academic standard;
- Any specific instructions given by the Council whenever this is the case are followed.

In addition to the orders requested on an as needed basis, the Provider shall keep regular communication with the Council to ensure continuing exchange of information relevant to the project implementation. This involves, among others, to inform the Council as soon as it becomes aware, during the execution of the Contract, of any initiatives and/or adopted laws and regulations, policies, strategies or action plans or any other development related to the object of the Contract (see more on general obligations of the Provider in Article 3.1.2 of the Legal Conditions in the Act of Engagement).

Unless otherwise agreed with the Council, written documents produced by the Provider shall be in English (see more on requirements for written documents in Articles 3.2.2 and 3.2.3 of the Legal Conditions in the Act of Engagement).

# C. FEES

Tenderers are invited to indicate their daily fees, by completing the table of fees, as attached in Section A of the Act of Engagement. These fees are final and not subject to review.

Tenders proposing fees above the exclusion level indicated in the Table of fees will be **entirely and automatically** excluded from the tender procedure.

The Council will indicate on each Order Form (see Section D below) the global fee corresponding to each deliverable, calculated on the basis of the daily fees, as agreed by this Contract

# D. HOW WILL THIS FRAMEWORK CONTRACT WORK? (ORDERING PROCEDURE)

Once this consultation and the subsequent selection are completed, you will be informed accordingly. Deliverables will then be carried out on the basis of Order Forms submitted by the Council to the selected Service Provider(s), by post or electronically, on **an as needed basis** (there is therefore no obligation to order on the part of the Council).

Each time an Order Form is sent, the selected Provider undertakes to take all the necessary measures to send it **signed** to the Council within 2 (two) working days after its reception.

# **Pooling**

For each Order, the Council will choose from the pool of pre-selected tenderersthe Provider who demonstrably offers best value for money for its requirements when assessed – for the Order concerned – against the criteria of:

- quality (including as appropriate: capability, expertise, past performance, availability of resources and proposed methods of undertaking the work);
- availability (including, without limitation, capacity to meet required deadlines and, where relevant, geographical location); and
- price.

If a Provider is unable to take an Order or if no reply is given on his behalf within that deadline, the Council may call on another Service Provider using the same criteria, and so on until a suitable Provider is contracted.

# Providers subject to VAT

The Provider, **if subject to VAT**, shall also send, together with each signed Form, a quote<sup>1</sup> (Pro Forma invoice) in line with the indications specified on each Order Form, and including:

- the Service Provider's name and address:
- its VAT number;
- the full list of services;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive):
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive .

# Signature of orders

An Order Form is considered to be legally binding when the Order, signed by the Service Provider, is approved by the Council, by displaying a Council's Purchase Order number on the Order, as well as by signing and stamping the Order concerned. Copy of each approved Order Form shall be sent to the Provider, to the extent possible on the day of its signature.

# E. ASSESSMENT

In case of non-compliance with the fees as indicated in the Act of Engagement, the Council of Europe reserves the right to terminate the Contract with the Service Provider, in all or in part.

Exclusion criteria (by signing the Act of Engagement, you declare on your honour not being in any of the below situations)<sup>2</sup>

Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence.

## Eligibility criteria

Tenderers shall demonstrate that they fulfil the following criteria (to be assessed on the basis of all supporting documents listed in Section F):

- A University Degreein a relevant field (social sciences, economy, law);
- Professional experience of at least three years at the national and/or international level in the fields of accessing funds under Operational Programmes in Bulgaria and assisting with or implementing projects funded under the mentioned sources;
- Excellent oral and written Bulgarian (at least level C1 of the CEFR<sup>3</sup>) and a good knowledge of English (at least level B2 of the CEFR);

#### Award criteria

- Criterion 1: Quality of the offer (80%), including:
  - Thematic knowledge and related expertise and experience in fields of accessing funds under Operational Programmes in Bulgaria and assisting with or implementing projects funded under the mentioned sources;
  - Experience in providing training on topics relevant to the field of this Call (diploma and/or certifications in project management, project development / access to funding, public procurement would be considered an advantage)
  - Capacity to adapt to the context and apply the technical expertise to the needs of target groups of the Programme, hence local administrations and marginalized communities, including Roma;
  - Demonstrated understanding of the delivery of national and international technical assistance projects;
- Criterion 2: Financial offer (20%).

The Council reserves the right to hold interviews with eligible tenderers.

Multiple tendering is not authorised.

# ARTICLE 1 – IDENTIFICATION OF THE CONTRACTING AUTHORITY

#### 1.1 Name and address

## **Background**

The activities of the Organisation are governed by its Statute. These activities concern the promotion of human rights, democracy and the rule of law. The Organisation has its seat in Strasbourg and has set up external offices in about 20 member and non-member states (in Ankara, Baku, Belgrade, Brussels, Bucharest, Chisinau, Erevan, Geneva, Kyiv, Lisbon, Moscow, Paris, Podgorica, Pristina, Rabat, Sarajevo, Skopje, Tbilisi, Tirana, Tunis, Warsaw, Venice and Vienna).

Council of Europe procurements are governed by the Financial Regulations of the Organisation and by Rule 1333 of 29 June 2011 on the procurement procedures of the Council of Europe.

The Organisation enjoys privileges and immunities provided for in the General Agreement on Privileges and Immunities of the Council of Europe, and its Protocols, and the Special Agreement relating to the Seat of the Council of Europe.<sup>5</sup>

Further details on the project are provided in the Terms of Reference.

#### **ARTICLE 2 - VALIDITY OF THE TENDERS**

Tenders are valid for 120 calendar days as from the closing date for their submission.

#### ARTICLE 3 - DURATION OF THE CONTRACT

The duration of the framework contract is set out in Article 2 of the Legal Conditions in the Act of Engagement.

# ARTICLE 4 – CHANGE, ALTERATION AND MODIFICATION OF THE TENDER FILE

Any change in the format, or any alteration or modification of the original tender will cause the immediate rejection of the tender concerned.

## ARTICLE 5 - CONTENT OF THE TENDER FILE

The tender file is composed of:

- Technical specifications/Terms of reference;

- An Act of Engagement, including the Legal Conditions of the contract

#### ARTICLE 6 - LEGAL FORM OF TENDERERS

The tenderer must be either a natural person, or a duly registered company under sole proprietorship of a natural person, or equivalent, provided that the signatory of the Act of Engagement is individually liable for all obligations undertaken by the entity, and is the owner of the moral rights in any creations of the entity. If contracted by the Council of Europe, the signatory of the Act of Engagement shall provide the deliverables personally, in accordance with the terms as provided in

the current Tender File, Act of Engagement and future Order Forms (see Section Dabove on ordering procedure).
